I am submitting, and may subsequently submit, to Gleb Kaminer Productions, LLC, certain material described below for Gleb Kaminer Productions, LLC's consideration. I understand and agree that Gleb Kaminer Productions, LLC may share the submitted material with other individuals for their review and consideration.

I realize that Gleb Kaminer Productions, LLC's files are full of ideas and stories (in screenplay, synopsis tape or other form) for theatrical and television programs and that ideas and stories are constantly being submitted to and developed by Gleb Kaminer Productions, LLC. Because many stories and ideas have similar or identical themes, I realize that there is a possibility that the submitted material may be similar to or identical to other material that has or may come to Gleb Kaminer Productions, LLC from other sources. As a result, I recognize that unless Gleb Kaminer Productions, LLC can obtain adequate protection in advance, you will refuse to accept, review, and consider the submitted material. The protection for Gleb Kaminer Productions, LLC must be broad enough to protect Gleb Kaminer Productions, LLC, its related companies, all its employees, agents, licensees, and assignees and all parties to whom Gleb Kaminer Productions, LLC submits materials. Thus, all references to Gleb Kaminer Productions, LLC in this letter include each and all of those persons.

In consideration of the foregoing, and as an inducement for Gleb Kaminer Productions, LLC's agreeing to accept and review my submitted material, I represent, warrant, and agree as follows:

1. The material is being submitted by me voluntarily and not in confidence. No confidential relationship is intended or created between us by reason of the submission of the Material. Also, nothing in this agreement nor the submission shall place Gleb Kaminer Productions, LLC in a different position from any other member of the public with respect to the submitted material so that if any part of the submitted material could be used freely by any member of the public, it may be used by Gleb Kaminer Productions, LLC without liability to me.
2. Gleb Kaminer Productions, LLC agrees that it will not use the submitted material unless it enters into an agreement with me granting it the right to use the submitted material or determines in good faith that it has the legal right to use all or part of the submitted material because (i) I do not own or control such material for any reason or (ii) those features or elements of the material Gleb Kaminer Productions, LLC uses have been independently developed by it or obtained from other sources, including Gleb Kaminer Productions, LLC's own employees.
3. I created the submitted material, it is wholly original with me, and Gleb Kaminer Productions, LLC need not secure permission from any other person but me to use the material.
4. In no event shall Gleb Kaminer Productions, LLC's review of the submitted material or any discussions or negotiations we may have imply any agreement to use or compensate me for the use of the submitted material.
5. If I should bring an action against Gleb Kaminer Productions, LLC for wrongful appropriation of the submitted material or any related claim and should I be unsuccessful in such action, I assume and agree to pay to Gleb Kaminer Productions, LLC all of its reasonable costs and expenses incurred in defending or contesting such action, including without limitation, court costs, attorneys' fees, and fees for any expert(s). Further, under no circumstances will I be entitled to an injunction or other equitable relief other than a declaratory judgment as to whether Gleb Kaminer Productions, LLC misappropriated the submitted material. My sole remedy shall be an action at law for damages, if any.
